Investment policy

The Fund follows a balanced strategy, investing approximately 50% in Shariah-compliant equities and 50% in income assets, including Sukuk and short-term Murabaha.

It aims to achieve diversified, risk-adjusted returns through a top-down, forward-looking allocation across asset classes, regions, and investment themes.

The Fund is measured against a blended benchmark comprising Dow Jones Islamic Market World Total Return Index (50%), Saudi interbank rates (25%), and Dow Jones Sukuk Total Return Index ex-reinvestment (25%).

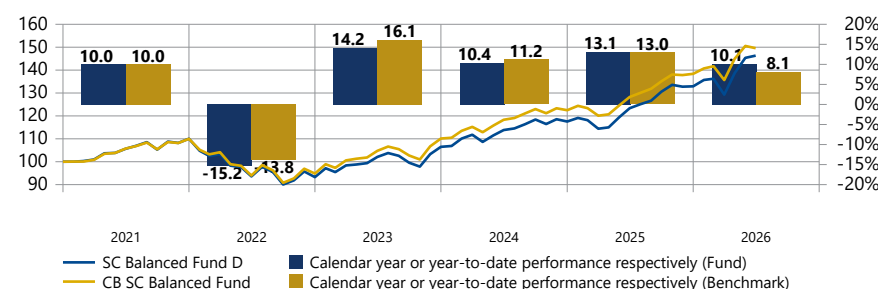

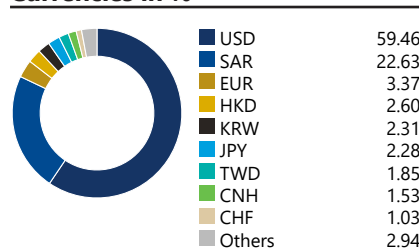

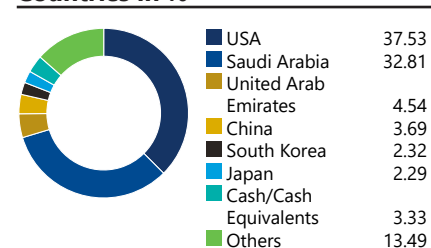

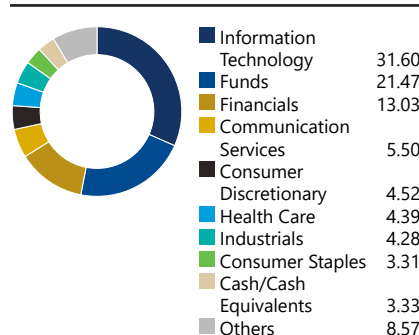
Currencies in %
