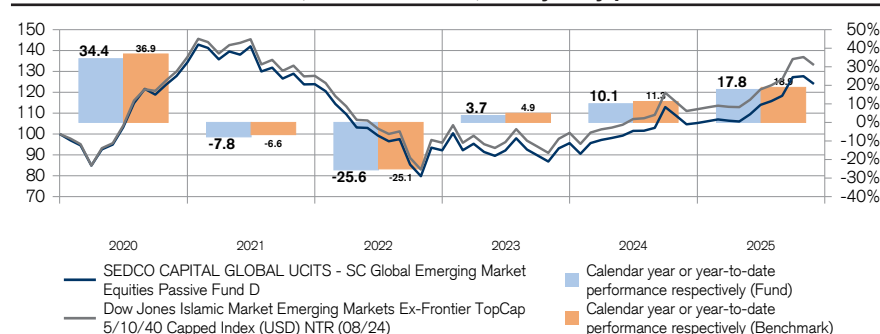

#### Net Performance in USD (rebased to 100) and yearly performance <sup>1)</sup>



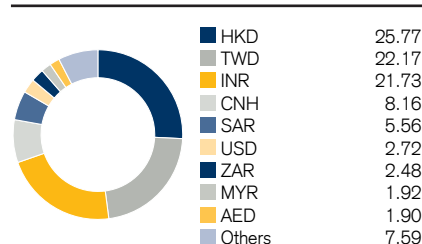

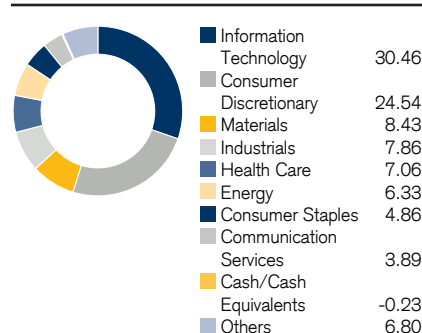

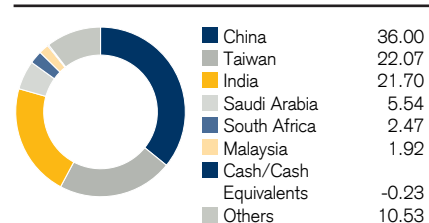
