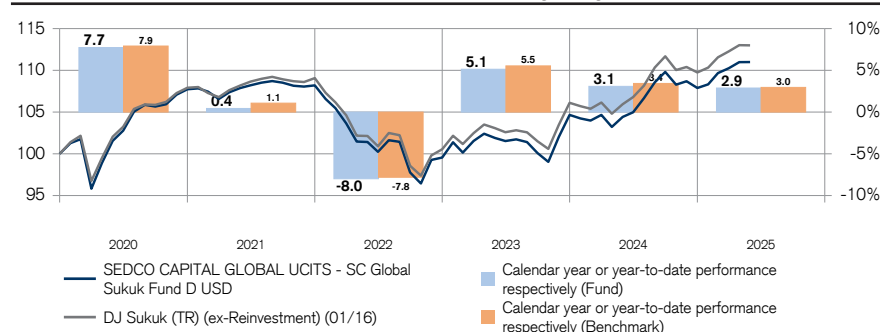

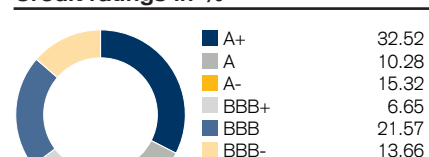

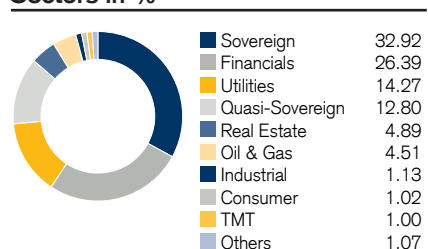

### Credit ratings in % <sup>2)</sup>

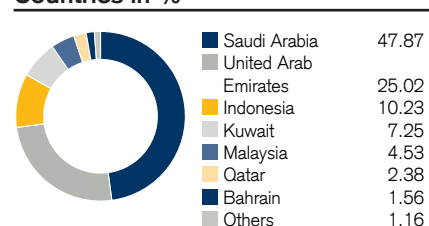
