
Investment policy

The Fund aims to invest directly, in accordance with the Shariah Investment Guidelines and the Investment Restrictions, in all or substantially all of the underlying equity securities of the Dow Jones Islamic Market Global Tech Titans 50 5/ 10/40 Capped Index (USD) NTR (Bloomberg ticker code: DJIMGCUN) (the "Benchmark"). The Fund will seek to replicate the performance of the Benchmark whilst minimising the Tracking Error between the Fund's performance and that of the Benchmark.


